



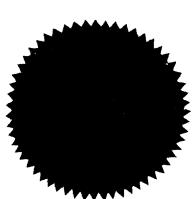

CERTIFICATE OF AMENDMENT

WIUTON LUMBER COMPANY, a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware

DOES HEREBY CERTIFY:

FIRST: That at a meeting of the Board of Directors of said WINTON LUMBER COMPANY duly held and convened, a resolution was duly adopted setting forth an amendment proposed to the certificate of incorporation of said corporation as follows:

"FURTHER RESOLVED, that the certificate of incorporation of the corporation be amended by striking out all of that Article thereof numbered "FCURTH" and by inserting in lieu thereof the following:

"FCURTH: That total number of shares which the corporation shall have authority to issue is twenty-three thousand seven hundred ninety-seven (23,797); all of such shares shall be without par value."

and declaring said amendment advisable and calling a meeting of the stockholders of said corporation for consideration thereof.

STCOND: That thereafter, pursuant to the aforesaid resolution of its board of directors, a special meeting of the stockholders of said cornoration was duly called and held, at which meeting the necessary number of stockholders as required by statute voted in favor of the amendment.

THIRD: That said amendment was duly adopted in accordance with the provisions of Section 26 of the General Corporation Law of Delaware as amended.

FOURTU: That the capital of said corporation will not be reduced under or by reason of said amendment.
