ARTICLES OF INCORPORATION

The undersigned natural person of the age of eighteen years or more, acting as incorporator under the Idaho Business Corporation Act, Idaho Code §30-1-1, et seq., adopts the following Articles of Incorporation:

ARTICLE 1. The name of this corporation is FRAME JOB, INC. and its duration shall be perpetual.

ARTICLE 2. The purpose for which the corporation is organized shall be for the conducting of the business of retail sales of frames, posters and miscellaneous supplies, and any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

ARTICLE 3: The aggregate number of shares which the corporation shall have authority to issue is 1,000 shares common stock, par value at \$0.10.

ARTICLE 4: The initial By-Laws of this Corporation shall be adopted by the Board of Directors, and such Board of Directors shall have the power to alter, amend or repeal, or adopt new By-Laws, and such By-Laws may contain any provisions for the regulation and management of the affairs of the Corporation not inconsistent with law or these Articles of Incorporation.

ARTICLE 5: The address of the initial registered office of the corporation is: 305 West Fort Street, Boise, Idaho, and the name of its initial registered agent at such address is: Donald W. Lojek.


