NAME

The name of this corporation is DEAN E. DONALDSON,

ARTICLE II
DURATION

This corporation shall have perpetual existence.

The director(s) of the corporation is released from personal liability to the corporation or its shareholders to the extent provided in Idaho Code Section 30-1-54(2).


