DESIGNATION OF AGENT, AND ACCEPTANCE OF THE PROVISIONS OF THE CONSTITUTION OF THE STATE OF IDAHO.

And the said The Oregon Railroad & Navigation Company does hereby revoke the authority heretofore granted to w. F. Kettenbach to act as its agent within the State of Idaho upon whom process might be served.
