

ARTICLES OF INCORPORATION  
OF  
JAMES M. McNAMARA, P.A.

The undersigned, who is duly licensed to practice the profession of performing dental services in the State of Idaho, desires to form a professional corporation pursuant to Section 30-1301, Idaho Code, for the purpose of rendering dental services, and adopt the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation shall be:

JAMES M. McNAMARA, P.A.

ARTICLE II

The purpose for which the corporation is formed is to engage in the general practice of dentistry.

In connection with the above-mentioned purpose, the corporation shall have the power to invest its funds in real property and securities, to acquire, own and dispose of real and personal property, and to do all other acts to the extent permitted under Section 30-1301, Idaho Code.

ARTICLE III

The post office address of the principal office of the corporation in the State of Idaho is Route #4, Box 865, Rathdrum, Idaho 83858, with the designated agent at said address being James M. McNamara.

ARTICLE IV

The name and post office address of each incorporator is:

ARTICLE V

The corporation shall be governed by a board consisting of one (1) director. The director shall be a stockholder in the corporation.

The number of directors constituting the initial board of directors is one (1), and the name and post office address is:

ARTICLE VI

The aggregate number of shares of stock that the corporation is authorized to issue is 500 shares, which shares shall be common stock having a par value of \$100.00 per share. Stock shall be issued only to persons who are licensed to practice dentistry in the State of Idaho.


ARTICLE VII
