

**ARTICLES OF INCORPORATION**

**BRUCE L. DENNEY, C.P.A., P.A.**

The undersigned natural person being of legal age, acting as incorporator under the provisions of the Idaho Professional Service Act, hereby adopts the following Articles of Incorporation:

**ARTICLE I**

**NAME**

The name of the corporation is **BRUCE L. DENNEY, C.P.A., P.A.**

**ARTICLE II**

**PERIOD OF DURATION**

The duration of this corporation is to be perpetual.

**ARTICLE III**

**PURPOSES AND POWERS**

## **ARTICLE IV**

### **CAPITAL STOCK**

**The aggregate number of shares which the corporation shall have authority to issue is fifty (50) shares of common stock, all of one class without par value.**

## **ARTICLE V**

### **INITIAL REGISTERED OFFICE AND AGENT**

**The initial registered office of the corporation is 525 Park Avenue, Suite 2E, Idaho Falls, Idaho 83402; The name of the initial registered agent at that office is Bruce L. Denney, C.P.A.**

## **ARTICLE VI**

### **DISTRIBUTIONS**

**The shareholder of the corporation may, from time to time, distribute to himself out of capital surplus of the corporation a portion of its assets, in cash or property, subject to the following provisions;**

- (a) No such distribution shall be made at a time when the corporation is insolvent or when such distribution would render the corporation insolvent;**
- (b) No such distribution shall be made unless it is authorized by the affirmative vote of the holders of a majority of the outstanding shares;**

(c) Each such distribution, when made, shall be identified as a distribution from capital surplus and the amount per share disclosed to the stockholder receiving the same concurrently with the distribution thereof.
