

ARTICLES OF INCORPORATION

of the

SMART AND WEBSTER LIVE STOCK COMPANY.

Now all men by these presents:

That we the undersigned have this day associated ourselves together for the purpose of forming a corporation under and by virtue of the laws of the State of Idaho, and by these presents do adopt the following Articles of Incorporation.

ARTICLE I.

That the corporation hereinafter formed shall be called and known by the name of the SMART AND WEBSTER LIVE STOCK COMPANY.

ARTICLE II.

The object, business and purpose of this corporation is and shall continue to be to breed, raise, buy, sell, trade or otherwise acquire or dispose of any and all kinds of live stock. To buy, sell or otherwise acquire or dispose of such personal and real estate property as may be necessary for the transaction of its business.

ARTICLE III.

That the principal place of business of said corporation shall be at Rexburg, Fremont County, State of Idaho.

ARTICLE IV.

This corporation shall continue to exist for a period of fifty years unless sooner dissolved or disincorporated by operation of law.

ARTICLE V.

The number of directors of this corporation shall be five, who shall hold office for one year from the date of this corporation, or until their successors are duly elected and qualified, and the names and residences of the first five directors, who shall hold office for the first year, are as follows:

William H. Smart of Heber City, Wasatch County, State of Utah.  
James W. Webster of Rexburg, Fremont County, State of Idaho.

## ARTICLE VI.

The amount of the capital stock of the corporation shall be Seventy five (\$75,000.) thousand Dollars, divided into seven hundred and fifty shares at the face or par value of \$1000 per share.

## ARTICLE VII.

The amount of said capital stock which has been actually subscribed and fully paid is \$50,000<sup>00</sup>, and the following are the names and the persons by whom the same has been subscribed and paid, with the amount of their subscription set opposite their names, to-wit:
