

KNOW ALL MEN BY THESE PRESENTS that we, Ken Tamura, President, and George Tamura, Secretary, ~~respectively~~ of ~~of~~ Treasure Valley Seed Co., Inc., a corporation organized and existing under the provisions of the laws of the State of Idaho, DO HEREBY CERTIFY:




