ARTICLES OF INCORPORATION

OF

TREASURE VALLEY FOODS, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

Article I

NAME. The name of the corporation is TREASURE VALLEY FOODS, INC.

Article II

DURATION. The period of its duration is perpetual.

Article III

PURPOSES. The purposes for which the corporation is organized are:

1. To engage in the business of processing or otherwise preparing fruits, vegetables and all other kinds of foods and food products for sale at wholesale or retail and to carry on all activities connected with the operation of such business.

2. To engage in the transaction of any or all other lawful business for which corporations may be incorporated under the provisions of Chapter 1, Title 30 of the Idaho Code and any amendments thereto.

Article IV

STOCK. The aggregate number of shares which the corporation shall have authority to issue is 10,000. Said stock shall be of one class designated as common stock with a par value of \$100.00 per share.

Article V

PREEMPTIVE RIGHTS. There are no provisions denying preemptive rights.

Article VI

INTERNAL AFFAIRS. There are no provisions for the regulation of the internal affairs of the corporation.

Article VII

REGISTERED OFFICE AND REGISTERED AGENT. The address of the initial registered office of the corporation is, 216 8th Street North, Nampa, Idaho 83651, and the name of its initial registered agent is, Wm. F. Gigray, Jr., Dearborn Building, 824 Dearborn Street, Caldwell, Idaho 83605.


