

Articles of Incorporation Of the Mason Creek Ditch Company

Know All Men by these presents: That we, the undersigned resident freeholders of Idaho Territory, have this day voluntarily associated our selves together for the purpose of forming a Corporation under and by virtue of the laws of the Territory of Idaho and to that end we do hereby make, execute and acknowledge this Certificate; and we do hereby certify and declare:

First: That the corporate name of this Corporation shall be The Mason Creek Ditch Company.
Second. That the purposes for which this Corporation is formed, are to construct purchase and maintain a water ditch or ditches to purchase locate and hold water rights in connection therewith and for the use and sale of water for irrigation.

Third. That the place where its principal business is to be transacted shall be at the Mason Creek School House, in Ada County Idaho Territory.

Fourth. That the term for which it is to exist shall be fifty years from and after the date of its incorporation.

Fifth. That the number of its Directors shall be five and that the names and residences of those who are appointed for the first year are:

Sixth: That there shall be no Capital Stock.

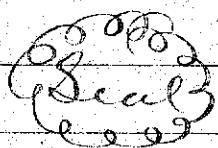
