AMENDED AND RESTATED ARTICLES OF INCORPORATION OF

RETIREMENT LIVING CONCEPTS, INCORPORATED, FORMERLY KNOWN AS SANDPOINT CONVALESCENT SERVICES, INC.

Retirement Living Concepts, Incorporated, formerly known as Sandpoint Convalescent Services, Inc., pursuant to Idaho Code Section 30-1-64, hereby restates its Articles of Incorporation as theretofore amended by a resolution adopted by the Board of Directors at its special meeting on June 1, 1993. The following relates to the amendment of the Articles of Incorporation:

- 1. The date of the adoption of the amendment was June 1, 1993.
- 2. The number of shares of each class entitled to vote on the amendment was one hundred (100) shares of the one (1) class of common stock.
