RESTATED ARTICLES OF INCORPORATION
OF POWER COUNTY DOMESTIC VIOLENCE SUPPORT GROUP, INC.

The following Restated Articles of Incorporation, duly adoped pursuant to the authority and provisions of Idaho Code §30-326 and §30-327, supersede and take the place of existing Articles of Incorporation and amendments thereto:

ARTICLE ONE

NAME

The name of the corporation is Power County Domestic Violence Support Group, Inc.

ARTICLE TWO

DURATION

The period of duration is perpetual.

ARTICLE THREE

**PURPOSE** 

Its purpose is to establish an ongoing program of aid for victims of domestic violence to include maintaining crisis line contact, temporary shelter, counseling and associated support services for citizens of Power County and the Southern Bingham County area.

This corporation is organized exclusively for religious, charitable, scientific, literary, or educational purposes within the meaning of section 501(c)(3) of the Internal Revenue Code. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code.

#### ARTICLE FOUR

## WINDING UP AND DISSOLUTION

Upon the winding up and dissolution of the corporation, after paying or adequately providing for the debts and obligations of the corporation, the remaining assets shall

be distributed to a non-profit fund, foundation or corporation which has established its exempt status under section 501(c)(3) of the Internal Revenue Code.
