

Dear City Clerk: *Jewell*

At long last the Attorney General, the Secretary of State and we have finalized the procedure and are beginning to issue Certificates of Incorporation.

We just this morning made the decision on the style of printing, the size and quality of paper on which they will be printed. Think they will be a very attractive document, and one you will like and want to put in a very nice frame to hang in city hall.

In reviewing the information sent in by the cities, we find certain items of information missing and necessary before the certificate can be issued.

In the case of Kuna we need a copy of the minutes of the meeting of the Ada County Commissioners at which they approved the incorporation of Kuna. The date does not appear on your seal. If you will write to Clarence Planting, Ada County Clerk, and ask him to look in his minute book at about the date of Sept. 15, 1915 he should find this. Am sure he would do this for you if you'll drop him a letter or call him. When we get this we'll send it in and you will get your certificate.

You should be able to get copies of all necessary information from your County Recorders office. We must have this information before the certificate can be issued to the city.
