We, the undersigned, being three or more natural persons of full age, at least two-thirds of who are citizens of the United states or of its territories or possessions, have this day, voluntarily associated ourselves for the purpose of forming a private corporation under the laws of the State of Idaho, and to that end hereby adopt Articles of Incorporation as follows:

ARTICLE ONE

NAME OF CORPORATION

ARTICLE FIVE

STOCK

The total authorized number of par value shares of stock is Ten Thousand (10,000), each having a par value of One Dollar (\$1.00). The aggregate par value of the total authorized number of par value shares is Ten Thousand Dollars (\$10,000.00). There are no authorized shares without par value.

The stock of the corporation is divided into 10,000 shares of a single class, each share having equal rights and each share having one (1) vote. All stock when fully paid shall be a nonassessable.

ARTICLE SIX

BOARD OF DIRECTORS AND BY-LAWS

The corporation shall have the power to establish a Board of Directors and adopt appropriate by-laws. The duties of the Board of Directors and its officers shall be established by the by-laws of the corporation. The Board of Directors shall have the authority to amend the by-laws of the corporation by a vote of a simple majority of the Board of Directors. However, the Board of Directors shall not have the power to sell the business nor to sell a significant part of the corporation assets without first obtaining the approval of two-thirds (2/3) of the shareholders in the corporation. Each member of the Board of Directors shall be a shareholder of the corporation.
