1. NAME

Any repeal or modification of the foregoing provisions of this Article by the shareholders of the Corporation, or any repeal or modification of applicable law that permits the elimination of liability of directors by this Article, shall not affect adversely any right, protection, or elimination of liability of a director of the Corporation with respect to any breach, act, omission, or transaction of such director occurring prior to the time of such repeal or modification.

8. INDEMNIFICATION

The Corporation shall defend and indemnify the directors and officers of the Corporation to the fullest extent permitted by law.

AMENDMENTS

These Articles of Incorporation may be amended in any manner now or hereafter prescribed or as permitted by statute. All rights of shareholders of the Corporation are granted subject to such reservation.
