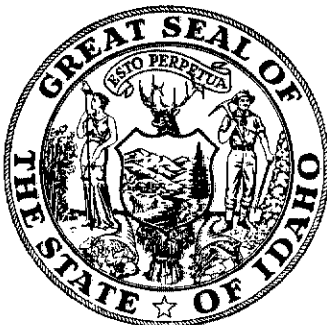

ARTICLES OF INCORPORATION
OF
MOTOR VILLAGE DETAIL INC.

The undersigned, desiring to act as a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such Corporation.

FIRST: The name of the Corporation is:

Motor Village Detail Inc.

SECOND: The period of its duration is perpetual.

THIRD: The Purpose or purposes for which the corporation is organized is the transaction of any or all lawful businesses for which corporations may be incorporated under the Idaho Business Corporation Act, including the conduct of an automobile detailing, washing, and appearance maintenance business.

FOURTH: The total authorized stock of this corporation shall be divided into 100 shares of a single class, all of which shall be without nominal or par value.

FIFTH: There are no provisions denying preemptive rights.


