ARTICLES OF INCORPORATION

ASHBY CYCLE RENTALS, INC.

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, being natural persons of full age, and citizens of the United States of America, and residents of the State of Idaho, in order to form a corporation for the purposes hereinafter stated, pursuant to the Business Corporation Act of the State of Idaho, do hereby certify as follows:

I

That the name of said corporation is "ASHBY CYCLE RENTALS, INC."

II

That the purposes for which said corporation is formed are:

To enter into a general rental business for the renting and leasing of new and used motor vehicles, including automobiles, motorbikes, motorcycles and tractors of all sizes and description; to do and perform all other acts which may be incidental to the proper carrying out of said business.

To own, rent, lease or maintain any building or buildings necessary for the housing and carrying on of the purposes of this business.

To acquire, own, hold, sell, lease, pledge, mortgage or otherwise dispose of any property real or personal, necessary to the operation of "ASHBY CYCLE RENTALS, INC."

To borrow money, contract debts, make contracts and to exercise any and all such powers as a natural person can lawfully make, do, perform or exercise, which may be necessary, convenient or expedient for the accomplishment of any of its objects or purposes provided the same shall not be inconsistent with the laws of the State of Idaho and to that end, innumeration of such powers shall not be deemed conclusive. Such corporation shall have the power to own

and acquire real and personal property of any and all description necessary to the convenient carrying on of its business.
