



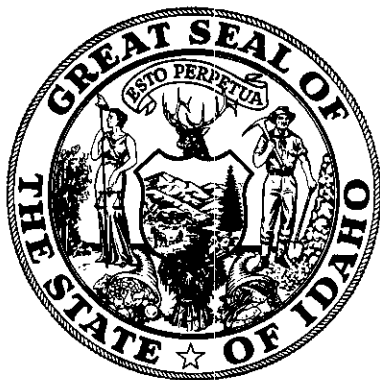
CERTIFICATE OF INCORPORATION

ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS:

THAT WE, the undersigned, natural persons of full age, citizens and residents of the United States of America, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and do hereby certify as follows:

ARTICLE I.

The name of the Corporation shall be:

LITTLE DIPPER RANCH, INC.

ARTICLE II.

The Corporation is formed for the following purposes:

1. For the pursuit of the business of agriculture, including, but not limited to, the raising and marketing of plants for food or fiber, and livestock.

2. For the acquisition, development and sale of real and personal property necessary or incidental to the pursuit of the business of agriculture.

3. For all other business matters necessarily or incidentally related to said primary purposes.

4. For the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act, Idaho Code §30-1-1, et seq.

ARTICLE III.

The duration of the Corporation shall be perpetual.

#### ARTICLE IV.

The Corporation is authorized to issue one class of shares, in a total amount of 5,000 shares, each share of stock bearing a par value of \$100.00. Shares of stock of this Corporation shall not be transferred or sold until said sale shall be approved by the Board of Directors of this Corporation, in accordance with the duly adopted By-laws of this Corporation.

The Capital stock of this Corporation, after the amount of the subscription price or par value has been paid in, shall not be subject to assessment and no paid up stock and no stock issued as fully paid shall be assessed or be assessable.

No private property of the stockholders of the Corporation shall be subject to or liable for the payment of corporate debts.


ARTICLE IX.


