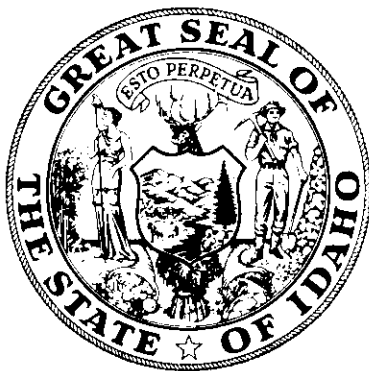

ARTICLES OF INCORPORATION
OF
DISCOUNT VIDEO, INC.

KNOW ALL MEN BY THESE PRESENTS, that I the undersigned being of full legal age and a citizen of the United States, have this day voluntarily formed a corporation under the laws of the State of Idaho, and hereby adopt Articles of Incorporation as follows:

I

The name of the corporation shall be DISCOUNT VIDEO, INC.

II

The term of existence of this corporation shall be perpetual.

III

The nature of the business of the corporation, its objectives and purposes shall be to have and exercise all the powers now and hereafter conferred by the laws of the State of Idaho upon corporations organized pursuant to the laws under which this corporation is organized and any and all acts amendatory thereof and supplemental thereto.

IV

The registered office of the corporation shall be located at 819 Dover Highway, Suite 28, Sandpoint, Idaho. The mailing address shall be P.O. Box 856, Sandpoint, Idaho 83864. The registered agent upon whom service may be effected on behalf of the corporation shall be Steven Wuerst.

The total authorized number of par value shares of stock is 10,000. The shares have a par value of \$1 per share. The aggregate par value of the total authorized number of shares is \$10,000. Said stock shall be of a single class and shall have equal rights

and voting power.




