
CERTIFICATE OF INCORPORATION OF

KNOW ALL MEN BY THESE PRESENTS, THAT WE, THE UNDERSIGNED BEING
NATURAL PERSONS OVER THE AGE OF EIGHTEEN (18) YEARS, DO HEREBY FORM
A PROFESSIONAL SERVICE CORPORATION UNDER THE LAWS OF THE STATE OF
IDAHO AS CONTAINED IN TITLE 30, CHAPTER 13, OF THE IDAHO CODE
ENTITLED "PROFESSIONAL SERVICE CORPORATIONS", AND TO THAT END DO
HEREBY SET FORTH:

1. THE NAME OF THE CORPORATION IS: LAW OFFICES OF WOOD & SHAW, PROFESSIONAL ASSOCIATION.
2. THE PERIOD OF DURATION OF THIS CORPORATION SHALL BE PERPETUAL.
3. THE PURPOSES FOR WHICH THIS CORPORATION IS ORGANIZED:
 - (A) PRIMARILY TO ENGAGE IN THE BUSINESS OF OPERATING A LAW OFFICE.
 - (B) THE TRANSACTION OF ANY OR ALL LAWFUL BUSINESS FOR WHICH SUCH CORPORATIONS MAY BE INCORPORATED UNDER THE IDAHO PROFESSIONAL SERVICE CORPORATION ACT.
4. THE COUNTY IN THE STATE OF IDAHO WHERE THE PRINCIPAL OFFICE FOR THE TRANSACTION OF BUSINESS OF THE CORPORATION IS LOCATED IS IN THE COUNTY OF BANNOCK AND THE NAME OF THE REGISTERED AGENT IS STEVEN G.
