The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Idaho.

**ARTICLE I: NAME**

The name of the corporation is TVHS, Inc.

**ARTICLE II: NATURE OF BUSINESS**

The corporation may engage in or transact any and all lawful activities or business permitted under the laws of the United States, the State of Idaho, or any other state, county, territory or nation subject to the laws of those jurisdictions.

**ARTICLE III: CAPITAL STOCK**

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 100,000 shares of common stock having no par value.

**ARTICLE IV: REGISTERED AGENT**

This corporation shall exist perpetually.

**ARTICLE VI: LIMITATION OF LIABILITY AND INDEMNIFICATION**

The Corporation shall indemnify the directors and officers of the corporation to the fullest extent permitted by the Idaho Business Corporation Act subject to the limitations herein. No Director shall be liable to the corporation or its stockholders for monetary damages for any action taken, or any failure to take any action, or any breach of duty except liability for: i) the amount of a financial benefit received to which he is not entitled; ii) an intentional infliction of harm on the corporation or the shareholders; iii) a violation of Section 30-1-833, Idaho Code; or, iv) an intentional violation of criminal law.

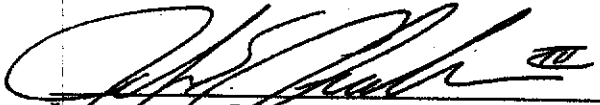
