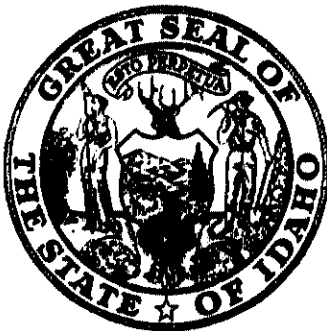
### CERTIFICATE OF INCORPORATION OF

## ARTICLES OF INCORPORATION

OF

SOFTWARE, INC.

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned natural persons of lawful age and citizens of the United States, for the purpose of forming a corporation pursuant to the provisions of the Idaho Business Corporation Act (Title 30, Idaho Code) do hereby certify as follows:

### FIRST

The name of the corporation is Software, Inc.

### SECOND

The corporation is to have perpetual existence.

### THIRD

The purposes and objects for which the corporation is organized include the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act (Title 30, Idaho Code).

### FOURTH

The aggregate number of shares which the corporation shall have authority of issue is: 100,000. Such shares are to consist of one class only. The par value of such shares shall be \$10, which stocks shall not be issued until fully paid for, and once issued shall be non-assessable.

FIFTH

All of the shares of stock issued shall be common stock and all shares shall have equal value, without preferences, limitations or differences in relative rights with respect to other shares.

SIXTH

Stockholders of the corporation shall have preemptive and preferential rights of subscription to any shares of stock of the corporation, whether now or hereafter authorized or to any obligations convertible into stock of the corporation or to obligations of the corporation convertible into stock. Any stock or obligations issued by the corporation shall first be offered to the stockholders of the corporation.

SEVENTH

The address of the initial registered office of the corporation is: 5180 E. Seltice Way, #C, Post Falls, ID 83854.

The name of the corporation's initial registered agent at such address is: Lawrence B. Young.

EIGHTH

The number of directors constituting the initial Board of Directors is 2 (Two).

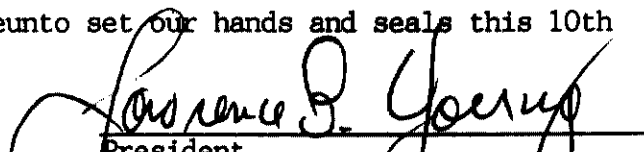

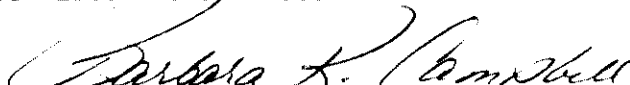
