ARTICLES OF INCORPORATION OF
CRAIG THOMAS FARM, INC.

The undersigned persons acting as incorporators for the purpose of forming a stock business corporation under the laws of the State of Idaho, adopts the following Articles of Incorporation:

Article 1: The name of the corporation is Craig Thomas Farm, Inc.

Article 2: The purpose for which this corporation is organized is to transact any and all lawful business for which corporations may be organized under the laws of the State of Idaho, and to have all powers which are afforded corporations under the laws of the State of Idaho.
