SETER ERICOLES OF INCORPORATION

OROFINO GOLF AND COUNTRY CLUB ASSOCIATION, We, the undersigned, Charles F. Frensdorf and D. B. Debertin, President and Secretary, respectively of Orofine Golf and Country Club Association, Inc., do hereby certify that at the Annual Meeting of members of said Corporation duly called and held on the 16th day of January 1979, at 7:30 o'clock P.M., the Resolution hereinafter set forth was adopted by a majority of the members of the Corporation, present at said meeting.

RESOLVED: That Article V. Section 3 of the Articles of Incorporation of Orofino Golf and Country Club Association, Inc., be, and the same hereby is, amended to read as follows:

ARTICLE V

Section 3. The membership fee in this Association shalk be the sum of Two Hundred Dollars (\$200.00). The voting power and property rights and interest of each member, whose fees are fully paid and who is in good standing, shall be one vote for each membership certificate owned. A member may own Six (6) certificates or 2 percent of the maximum 300 memberships available as provided in the Articles of Incorporation as amended. New members upon their admission in this Association shall be entitled to one vote for each certificate owned and to milities in the property of the Association equally with the old members on the basis of certificates owned. When a member has paid his membership fee in full he shall receive a membership certificate. Assessments against members and a determination of their liabilities shall be fixed by the By Laws of the Association.
