

ARTICLES OF INCORPORATION

OF

HARTMANS, INC.

The undersigned natural persons, citizens of the United States of America and residents of the State of Idaho, acting as incorporators, hereby adopt the following articles of incorporation:

ARTICLE ONE. NAME. The name of the corporation is Hartmans, Inc.

ARTICLE TWO. DURATION. The period of duration of the corporation is perpetual.

ARTICLE THREE. PURPOSES. The corporation is organized for a truck stop, service station, and restaurant business and for any incident, allied, or other lawful purpose.

ARTICLE FOUR. STOCK. The corporation is authorized to issue a total of 50,000 shares of stock, each share having a par value of \$100. Such shares shall be of a single class.
