- 1. NAME: The name of the corporation is FRIENDS OF ISU

  CORPORATION.
  - 2. DURATION: The period of its duration is perpetual.
  - 3. NON-PROFIT: This is a non-profit corporation.
- 4. <u>PURPOSES</u>: The purpose or purposes for which he corporation is organized are educational, social, fraternal, and any other lawful purposes for which corporations may be incorporated under the Idaho Non-profit Corporation Act.
- 5. BOARD OF DIRECTORS: The management of the affairs of this corporation is vested in the Board of Directors which shall consist of not less than three (3) or more than nine (9) members whose qualifications, term of office and election shall be prescribed in the By-laws of the corporation.
