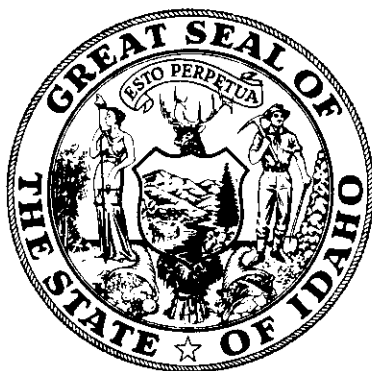

ARTICLES OF INCORPORATION

OF

Citizens For
~~FRIENDS OF~~ ISU CORPORATION

The undersigned, acting as incorporators of a corporation under the Idaho Non-Profit Corporation Act, Idaho Code, Title 30, Chapter 3, adopt the following Articles of Incorporation for such corporation:

1. NAME: The name of the corporation is *Citizens For* ~~FRIENDS OF~~ ISU CORPORATION.

2. DURATION: The period of its duration is perpetual.

3. NON-PROFIT: This is a non-profit corporation.

4. PURPOSES: The purpose or purposes for which the corporation is organized are educational, social, fraternal, and any other lawful purposes for which corporations may be incorporated under the Idaho Non-profit Corporation Act.

5. BOARD OF DIRECTORS: The management of the affairs of this corporation is vested in the Board of Directors which shall consist of not less than three (3) or more than nine (9) members whose qualifications, term of office and election shall be prescribed in the By-laws of the corporation.

The number of directors constituting the initial Board of Directors of the corporation is three (3) and the names and addresses of the persons who are to serve as directors until the first annual meeting of the shareholders or until their successors are elected and shall qualify are:






