*RE: Use of the Word "Bank" in Company Name in Idaho*

Dear Ms. Boyd:

The Idaho Department of Finance (Department) received your correspondence on April 24, 2025, requesting an approval letter to file with the Idaho Secretary of State to register and use the business name "Avidbank" in Idaho. We understand that Avidbank is a California-chartered bank based in San Jose, California. You indicated that an employee of Avidbank is an Idaho resident and will work remotely from Idaho for the bank.

Idaho Code § 26-1202 of the Act provides that "no person may advertise or transact business in this state under a name or title that contains the word 'bank,' 'banker,' 'bancorp,' 'savings bank,' 'trust company,' or a word or words of similar import, unless the person has been granted a charter to engage in banking or trust business in this state by the director, or unless the director has granted the person a waiver from this prohibition as set forth in this section." However, Idaho Code § 26-1202(2) states that the "prohibition shall not apply to a ... state-chartered bank or trust company located in another state that has obtained all approvals that may be required under the law as a prerequisite to doing business in this state." Since the statute does not apply to a state-chartered bank otherwise qualified, there is no need for the Director of the Department to grant a waiver to a state-chartered financial institution to use the word "bank" in its name in Idaho. Under these circumstances, the Department offers "no objection" to Avidbank's use of the word "bank" in its name and to registering to do business in Idaho.

If any of the facts or circumstances you have provided change, this agency's position on the matter could change.
