ARTICLES OF INCORPORATION

OF

IDAHO IRON, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is IDAHO IRON, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are: Contracting and erection of iron and metal work, steel reinforcing, maintenance work for industrial construction, and any and all types of iron work, and general contracting, together with the transaction of all other lawful business for which corporations may be incorporated under the Idaho Business Corporation Act, Section 30-1-3.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is Ten Thousand shares of \$1 par value common stock.

FIFTH: Shareholders shall have full preemptive rights.

SIXTH: Provisions for the regulation of the internal affairs of the corporation are such as may be provided by the By-Laws of the Corporation, including provision for restriction on transfer of shares, as provided in Idaho Business Corporation Act, Section 30-1-23A.

SEVENTH: The address of the initial registered office of the corporation is P. O. Box 752, Pocatello, Idaho 83201, and the name of its initial registered agent at such address is Dolores C. Wellard.

EIGHTH: The number of directors constituting the initial Board of Directors of the corporation is two, and the names and addresses of persons who are to serve as directors until the first annual meeting of Shareholders or until their successors are elected and shall qualify are:
