I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a corporation, by the name hereinbefore stated, for perpetual existence from the date hereof, with its registered office in this State located at **Pocatello** in the County of **Bannock** and as such are subject to the rights, privileges and limitations granted to Non-Profit cooperative Associations, as provided in Chapter 10, Title 30, Idaho Code.

ARTICLES OF INCORPORATION

O F

SEAGULL BOAT CLUB, *Inc.*

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, all of whom are citizens of the United States and of the State of Idaho, and being of lawful age, do hereby associate ourselves together for the purpose of forming a non-profit cooperative association under and pursuant to Chapter 10 of Title 30, Idaho Code, and we do hereby certify as follows:

I.

That the name of this corporation shall be SEAGULL BOAT CLUB, *Inc.*

II.

The purposes and objects for which this corporation is formed are as follows:

- (a) To serve the interests of all boat owners.
- (b) To defend such owners against discriminatory legislation and unjust taxation.
- (c) To prevent the pollution of neighboring recreational waters.
- (d) To stimulate a greater interest in boating among all citizens in the area served by the Club.
- (e) To develop a fraternal spirit among local outdoor enthusiasts.
- (f) To provide a medium for the exchange of boating information.
- (g) To develop more adequate boat storage and dock facilities.
- (h) To do all things which will tend to serve present owners of boating equipment and to further interest in boating generally.
- (i) To promote, conduct, provide, maintain and carry on any and all kinds of activities for the entertainment, diversion and recreation of the members of the association, and to promote the general welfare, social, educational and fraternal conditions of the Seagull Boat Club; and to that end, to buy, sell, hold, acquire, own, mortgage, hypothecate, convey, transfer, lease, exchange, trade and dispose of real and personal property.

To do all that is permitted by Chapter 10, Title 30 Idaho Code and other chapters and titles of said Code not in conflict therewith, and all such other acts as are necessary and expedient to accomplish its stated purposes.

**III.**

The corporation shall have succession by its corporate name perpetually, and the rights, interests and privileges of all members shall be equal, and no member can acquire a greater interest therein than any other member, and said corporation shall issue membership certificates to each member thereof.

**IV.**

The location and Post Office Address of its registered office in the State of Idaho shall be the City of Pocatello, Bannock County, Idaho.
