ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF WESTERN SILVER LEAD CORPORATION

Article I. Amendment

The Articles of Incorporation of the Corporation are amended as follows:

Article V. is deleted in its entirety and replaced with the following:

Article V.

The total authorized number of shares is 8,000,000 having a par value of \$0.001, or an aggregate par value of \$8,000.

Said authorized shares shall be divided into two classes to be known as "Class A" and "Class B".

Class A shall consist of 4,000,000 shares which shall be fully paid and non-assessable.

Class B shall consist of 4,000,000 shares which shares shall be assessable. Provided, however, that any assessment levied upon Class B shares shall be considered as contribution to capital and shall be repaid from the net profits of the Corporation before any dividends are declared or paid upon either Class A or Class B shares.

After the repayment of all assessments levied upon the Class B shares, the Class A and Class B shares shall participate equally, share for share, in all dividends thereafter declared and paid.
