ARTICLES OF INCORPORATION

of

INLAND COMPANY

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, each of whom is a bona fide resident of the State of Idaho, of legal age, and a citizen of the United States of America, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and pursuant thereto, we hereby certify as follows:

ARTICLE I

The name of this corporation shall be:

INLAND COMPANY

ARTICLE II

The objects and purposes for which this corporation is formed are: As principal, agent, or otherwise to do in any part of the world any and every of the things herein set forth to the same extent as natural persons might and could do. In furtherance thereof, and not in limitation of the general powers conferred by the laws of the State of Idaho, we expressly provide that this corporation shall have the power:

(a) To purchase, acquire, own, improve, sell, convey, assign, lease, mortgage, release, encumber, buy, or deal in real or personal property of every kind and nature.

(b) To deal in, buy, sell, own or encumber stock

and security of other corporations; to loan money and take security for the payment of all amounts due the corporation and to assign or release such securities.

(c) To own and operate for profit motels, hotels, and lodging places; to own and operate for profit restaurants, bars, or any other establishment; to buy and sell beer and any other intoxicating beverage, so long as the same is legal under the laws of the state and nation wherein the same is done.

(d) To own, operate and engage in any retail or wholesale business and to purchase and sell for profit any and all goods, wares or merchandise, machinery, equipment or other real or personal property.

(e) To deal in placer or lode mining property; to own and operate such mining property; to own, lease, or operate farms and farming property.

(f) To engage in and conduct all phases of contract work, including designing, constructing and selling of homes, residences and business properties.

(g) To own, lease or operate any type of amusement.

(h) To own or operate any transportation company or any other private or public utility for profit.

(i) To enter into, make, perform, and carry out contracts of every kind, amount and character with any person, firm, association, partnership, or corporation and to take assignments of any contract.

(j) To sue and be sued.

(k) To own, lease or operate any type of printing establishment.

(l) In addition to the foregoing powers also to have all authority, powers and rights granted by the laws of the State of Idaho, or any other state wherein said corporation may operate.

(m) To purchase, acquire or own/^{its} common or preferred stock insofar as is not contrary to the laws of the State of Idaho.

(n) To do and perform every act and thing necessary to carry out the above enumerated purposes, or calculated directly or indirectly to further the interests or interest of the company or to the enhancement of the value of its stock, holdings, and property of every kind and character.

ARTICLE III

The registered office of this corporation and the principal place for the transaction of its business is hereby designated as: Boise, Ada County, Idaho

ARTICLE IV

This corporation shall have perpetual existence.

ARTICLE V

The number of directors of this corporation shall be three (3), and it is not necessary that a director be a shareholder of the corporation.

ARTICLE VI

The amount of the total authorized capital stock of this corporation is Twenty-Five Thousand (\$25,000.00) Dollars, divided into Five Thousand (5,000) shares of common stock of the par value of Five (\$5.00) per share.

Each share shall have full voting and dividend participating privilege and all of said stock shall be and remain non-assessable.

ARTICLE VII

The private property of the stockholders of this corporation shall not be subject to the payment of corporate debts to any extent whatsoever.

ARTICLE VIII

The amount of the capital stock of this corporation actually subscribed is five (5) shares each by the persons whose residences are herein set forth, to-wit:
