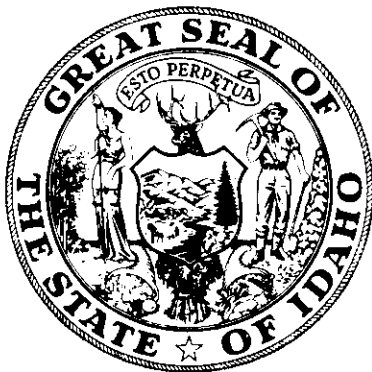

AMENDMENTS TO ARTICLES OF INCORPORATION

A special meeting of the members of Kootenai County Substance Abuse Council, Inc. was held on March 5, 1987 for the purpose of voting on two amendments to our Articles of Incorporation. A quorum was present at this meeting and the majority voted to amend the Articles as they appear below.

Please file the following amendments to our Articles of Incorporation, No. 81607 that were originally files with your office on June 25, 1986.

ARTICLE 2 should begin with the following addition: "This organization is organized exclusively for charitable purposes within the meaning of section 501(c)(3) of the Internal Revenue Code." The original Article 2 should then follow in its entirety.

The original ARTICLE 10 should be completely deleted and replaced with the following: "Upon the winding up and dissolution of this corporation, after paying or adequately providing for the debts and obligations of the corporation, the remaining assets shall be distributed to a nonprofit fund, foundation, or corporation which is organized and operated exclusively for charitable, educational, religious and/or scientific purposes and which has established its tax exempt status under section 501(c)(3) of the Internal Revenue Code."
