ARTICLES OF INCORPORATION

of

SEIGEL CREEK IDAHO MINING COMPANY.

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Washington, and to that end ~~we~~ do hereby certify:

ARTICLE I.

THE NAME of this corporation shall be "SEIGEL CREEK IDAHO MINING COMPANY"

ARTICLE II.

The objects for which this corporation is formed are:

First: To acquire by purchase, or otherwise, and to own, operate, sell, convey, lease and bond any and all mineral claims of every description and any other property which said corporation may acquire within the United States of America, Alaska, the province of British Columbia and such other places as the Board of Trustees may direct,

Second: To carry on the business of mining, and to acquire, by purchase or otherwise, to own, construct and operate all water rights, mills, railroads, machinery, buildings and appliances and property of whatsoever kind necessary and convenient to the proper working of said mines and the property that may be acquired by said corporation, or to the proper working or shipping of ores therefrom.

Third: To purchase from the subscribers to the capital stock such mining claims, or other property, as the Board of Trustees may deem proper and to receive such mining claims, and other property, in payment of subscriptions to the capital stock in such amounts as the Board of Trustees may think proper, and to issue fully paid up stock therefor.

ARTICLE III.

THE AMOUNT OF CAPITAL STOCK of this corporation shall be \$1,500,000 divided into 1,500,000 shares of the par value of one dollar (\$1.) per share.

ARTICLE IV.

The term for which this corporation is to exist is fifty years from

the date of this incorporation.

ARTICLE V.

The Principal Place of Business of this corporation shall be the city of Spokane, Spokane County, State of Washington, United States of America.

ARTICLE VI.

The Number of Trustees of this corporation shall be seven, and the names and residences of the trustees who are appointed to manage the affairs of this company until October 30, 1903, and until their successors are elected and qualified, are as follows, to-wit:
