The undersigned, acting as sole incorporator of a corporation under the Idaho Professional Service Corporation Act, adopt the following Articles of Incorporation for such corporation.

ARTICLE I

The name of the corporation shall be BOISE NEUROSURGICAL CLINIC, P.A.

ARTICLE II

The period of its duration is perpetual.

ARTICLE III

The corporation is formed for the purpose of engaging in the general practice of medicine by authority of and to the extent permitted by the Idaho Professional Service Corporation Act.

ARTICLE IV

All shareholders of the corporation are and will continually be licensed in the profession of medicine, and no professional service will be offered by the corporation except by and through licensed stockholders or licensed employees.

ARTICLE V

The corporation shall have authority to issue 25,000 shares with a \$1.00 par value.

ARTICLE VI

The transfer of the shares of the corporation is restricted and such restriction is specified in the bylaws of the corporation.

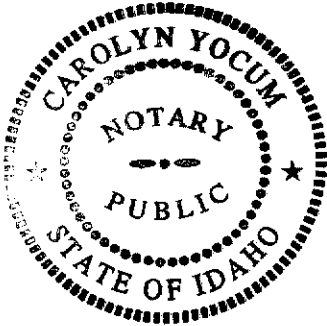
