



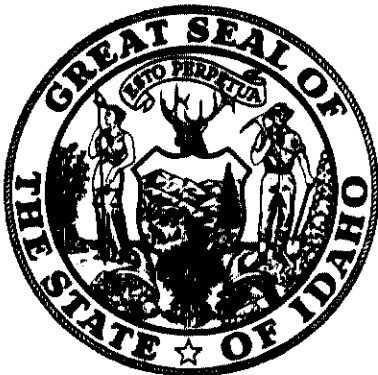

ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS: THAT WE, THE UNDERSIGNED, ACTING AS INCORPORATORS OF A CORPORATION UNDER THE IDAHO BUSINESS ACT, ADOPT THE FOLLOWING ARTICLES OF INCORPORATION FOR SUCH CORPORATION:

ARTICLE I

THE NAME OF THIS CORPORATION IS KOUNTRY KONNECTION, INC.

ARTICLE II

THE OBJECTS AND PURPOSES FOR WHICH THIS CORPORATION ARE FORMED ARE:

THE TRANSACTION OF ANY OR ALL LAWFUL BUSINESS FOR WHICH CORPORATIONS MAY BE INCORPORATED UNDER THE IDAHO BUSINESS CORPORATION ACT.

ARTICLE III

THE CORPORATION SHALL HAVE PERPETUAL EXISTENCE.

ARTICLE IV

THE LOCATION AND ADDRESS OF THE REGISTERED OFFICE OF THE CORPORATION SHALL BE AND IS: 3403 MEADOW DRIVE, BOISE, IDAHO, 83706 THE NAME AND ADDRESS OF THE REGISTERED AGENT IS: CHARLES T. LOPEZ, 3403 MEADOW DRIVE, BOISE, IDAHO, 83706.

ARTICLE V

THE AMOUNT OF THE CAPITAL STOCK OF THE CORPORATION SHALL BE 100,000 SHARES AND EACH SHARE SHALL HAVE NO PAR VALUE. SAID STOCK SHALL BE AND IS NON-ASSESSABLE.

#### ARTICLE VII

THE PRIVATE PROPERTY OF THE STOCKHOLDERS OF THE CORPORATION SHALL NOT BE SUBJECT TO THE PAYMENT OF CORPORATE DEBTS TO ANY EXTENT WHATSOEVER, AND THE SHARES OF THE CORPORATION SHALL NOT BE SUBJECT TO ASSESSMENT FOR THE PURPOSE OF PAYING EXPENSES, CONDUCTING BUSINESS OR PAYING DEBTS OF THE CORPORATION.

#### ARTICLE VIII


(A) THE CORPORATION SHALL NOT HAVE A BOARD OF DIRECTORS, BUT SHALL BE RUN AND MANAGED DIRECTLY BY THE SHAREHOLDERS. HOWEVER, THE CORPORATION RESERVES THE RIGHT AT ANY FUTURE DATE TO ELECT A BOARD OF DIRECTORS IF SUCH ACTION IS DEEMED ADVISABLE BY A MAJORITY OF THE SHAREHOLDERS.


(B) THE INCORPORATORS SET FORTH ABOVE ARE THE ONLY SHAREHOLDERS OF THE CORPORATION.

#### ARTICLE IX

NO CONTRACT OR OTHER TRANSACTION BETWEEN THE CORPORATION AND ANY OTHER CORPORATION AND NO ACT OF THE CORPORATION SHALL IN ANY WAY BE AFFECTED OR INVALIDATED BY THE FACT THAT ANY OF THE DIRECTORS OR SHAREHOLDERS OF THE CORPORATION ARE PECUNIARILY OR OTHERWISE INTERESTED IN OR ARE DIRECTORS OR OFFICERS OF SUCH OTHER CORPORATION; ANY DIRECTORS, INDIVIDUAL OR ANY FIRM OF WHICH ANY DIRECTOR OR SHAREHOLDER MAY BE A MEMBER, MAY BE A PARTY TO OR MAY BE PECUNIARILY OR OTHERWISE INTERESTED IN ANY CONTRACT OR TRANSACTION OF THE CORPORATION PROVIDED THE FACT THAT HE/SHE OR SUCH FIRM IS SO INTERESTED SHALL BE DISCLOSED OR SHALL HAVE BEEN KNOWN TO THE BOARD OF DIRECTORS OF SHAREHOLDERS OF THE CORPORATION WHICH SHALL AUTHORIZE ANY SUCH CONTRACT OR TRANSACTION WITH LIKE FORCE AND EFFECT AS IF HE/SHE WERE NOT SUCH OFFICER OR DIRECTOR OF SUCH OTHER CORPORATION OR NOT SO INTERESTED.




