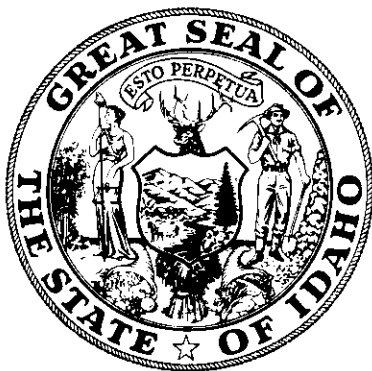

## ARTICLES OF INCORPORATION of the SNAKE RIVER AUDUBON SOCIETY, INC. August 5, 1982



1. The name of the corporation is the Snake River Audubon Society, Inc.
2. The corporation is a non-profit corporation.
3. The period of duration is perpetual.
4. The purpose for which the organization is incorporated is to engage exclusively in any such educational, scientific, literary, historical, and charitable pursuits as may be part of the stated purposes of the National Audubon Society, Inc. of which this Society shall function as a Chapter. (from Constitution)
5. As provided in the by-laws, the corporation shall have members who shall elect the Board of Directors.
6. The management of the affairs of the corporation shall be vested in the Board of Directors.
7. The number of directors of the corporation may be changed by the Board of Directors. Chairpersons of permanent committees are members of the Board of Directors. Thus, as provided in the by-laws, the Board of Directors shall appoint such committees as it deems necessary to conduct the business of the Society, thereby changing the number of directors.
8. The initial registered agent shall be:
