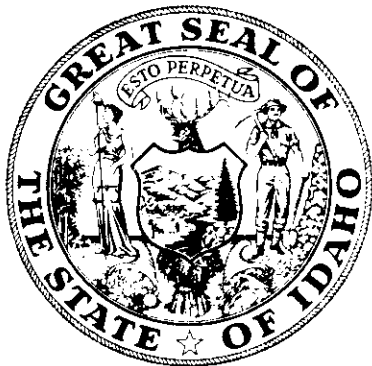

**ARTICLES OF AMENDMENT  
OF  
KLOEPFER, INC.**

These Articles of Amendment are made by Kloepper Inc., an Idaho corporation, pursuant to the Idaho Business Corporation Act, and in accordance with the provisions of such section the following information is set forth:

(a) The name of the corporation is Kloepper Inc.

(b) The Board of Directors of the Company has approved and the stockholders of the Company have adopted the following amendment:

ARTICLE 5 of the Articles of Incorporation shall be amended to read as follows:

ARTICLE 5  
CORPORATE STOCK

The aggregate number of shares of common stock which the Corporation shall have the authority to issue is 300,000 having a no par value. Each share shall participate equally in the earned surplus and dividends of the Corporation as well as share equally in the distribution of the assets of the Corporation upon dissolution and termination. There shall be one (1) class of common stock.

Such common stock shall be divided into voting common stock and non-voting common stock. Twenty-seven thousand (27,000) shares shall be designated as voting common and two hundred and seventy-three thousand (273,000) shares designated as

non-voting common. As between the voting and non-voting common the voting rights shall be the sole difference.

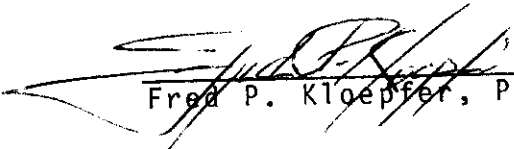
(c) The shareholders adopted the Amendment to the Articles of Incorporation on APRIL 3, 1987.

(d) There are 27,000 shares of stock outstanding, all of which shares are entitled to vote.

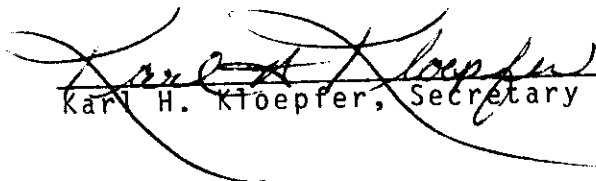
(e) All 27,000 shares voted for the Amendment to the Articles of Incorporation.
