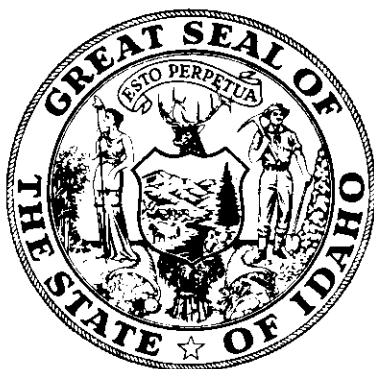

ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS:

THAT WE, the undersigned, natural persons of full age, citizens and residents of the United States of America, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and do hereby certify as follows:

ARTICLE I.

The name of the Corporation shall be:

JEROME MOBILE HOMES, INC.

ARTICLE II.

The purpose for which this Corporation is organized shall include the transaction of any lawful business for which corporations may be incorporated under the provisions of Idaho Code Title 30, Chapter 1.

ARTICLE III.

The duration of the Corporation shall be perpetual.

ARTICLE IV.

The Corporation shall be authorized to issue 2,000 shares of capital stock, each such share possessing a par value of \$100.00.

ARTICLE V.

The Corporation's registered office shall be 400 North Fillmore, Jerome, Idaho 83338. The Corporation's registered agent at said address shall be Kurt L. Thompson.

ARTICLE VI.

The names and addresses of the incorporators of this Corporation, which persons will also serve as the initial Board

of Directors of this Corporation and act as Directors until the first meeting of shareholders are:

#### ARTICLE VII.

The number, qualifications, terms of office, manner of election and powers and duties of Directors shall be fixed and may only be altered from time to time as provided in the By-laws. The persons above named as incorporators shall act in the capacity of Directors until their successors are elected and qualified.

#### ARTICLE VIII.

No private property of the stockholders of the Corporation shall be subject to or liable for the payment of corporate debts.

#### ARTICLE IX.



#### ARTICLE X.
