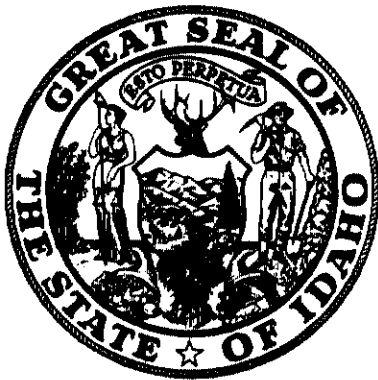
**CERTIFICATE OF INCORPORATION

ARTICLES OF INCORPORATION

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the Corporation is JD's AUTO BODY, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purposes for which the Corporation is organized is to operate an auto body repair facility together with all related activities and the transaction of any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the Corporation shall have authority to issue is 10,000 shares, with no par value per share.

FIFTH: There are no provisions denying pre-emptive rights.

SIXTH: The internal affairs of the Corporation shall be governed by a duly adopted Code of Bylaws which shall be consistent with these Articles of Incorporation and the laws of the State of Idaho.

SEVENTH: The address of the initial registered office of the Corporation is 1016 #A Main Street St. Maries, Idaho 83861,

County of Benewah, State of Idaho, and the name of the registered agent at such address is Jack D. Flerchinger.

EIGHTH: The number of directors constituting the initial Board of Directors of the Corporation is two (2), and the names and addresses of the persons who are to serve as directors until the first annual meeting of shareholders, or until their successors are elected and shall qualify, are:
