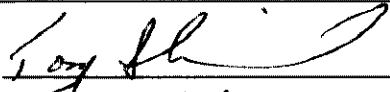

As you have been advised, Lions Clubs International and its member clubs and districts have received a group federal tax exemption 0239, under IRS Code Section 501(c)4. Each club and district is reported under this exemption by its Employers Identification Number (EIN) and is currently listed in the IRS records under the name of the club or district secretary as designated to receive information from the IRS.
