

ARTICLES OF INCORPORATION  
OF THE  
FIRST METHODIST EPISCOPAL CHURCH OF BLISS IDAHO.

Know all men by these presents, that we the undersigned, have associated ourselves together under the law of the State of Idaho as a body corporate.

Article I.

The name of this corporation shall be the First Methodist Episcopal Church of Bliss Idaho.

Article II.

The object of this corporation shall be the promotion of religious and benevolent work as a Pastoral Charge of, and subject to the provisions of the Discipline of the Methodist Episcopal Church in the United States of America.

Article III.

The term for which this corporation is to exist is fifty years.

Article IV.

The principal place of business of said corporation is Bliss Idaho.

Article V.

The title of the persons making these articles of incorporation are Trustees, of whom there shall be nine, to

be elected annually at the Fourth Quarterly Conference of said First Methodist Episcopal Church of Bliss Idaho, or as provided in the Discipline of said Church.

#### Article VI.

At a meeting held October Fourteenth, 1911, for the purpose of adopting articles of incorporation, in conformity with the Discipline, the following persons were elected Trustees by a majority vote of all qualified electors, to hold office until the next Fourth Quarterly Conference, or until their successors are elected and qualified.
