ARTICLES OF AMENDMENT
to the
ARTICLES OF INCORPORATION
of
HIGH DESERT RANCH, INC.

Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is HIGH DESERT RANCH, INC.

SECOND: No shares having been issued, the following amendment to the Articles of Incorporation was adopted by the sole incorporator of the Corporation on the 21st day of January, 1994, in the manner prescribed by the Idaho Business Corporation Act:

Article I is hereby amended to read as follows:

The name of this Corporation is JWC, INC., and its duration shall be perpetual.

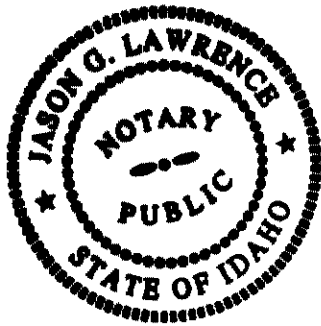
