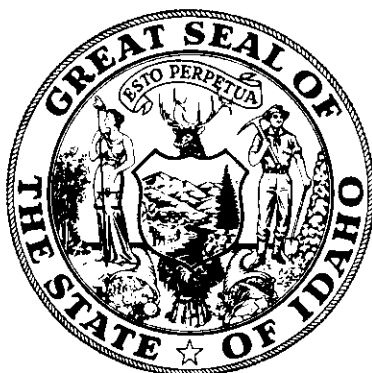

ARTICLES OF INCORPORATION

OF

REGION I PRIVATE INDUSTRY COUNCIL, Inc.

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, citizens of the United States and residents of the State of Idaho, do hereby associate ourselves together to form a non-profit corporation, and in order to form a corporation for the purposes hereinafter stated under and pursuant to the provisions of Chapter 10 of Article 30, Idaho Code, and the laws of the State of Idaho relating to the organization of corporations where pecuniary profit is not the object, and we do hereby certify and declare as follows:

I.

NAME

The name of this corporation is REGION I PRIVATE INDUSTRY COUNCIL, Inc.

II.

PLACE OF BUSINESS

The principal place of business and post office address of this corporation shall be at 105 North 4th, P.O. Box 880, Coeur d'Alene, Kootenai County, Idaho 83814. The corporation may have such other places of business as the directors shall hereafter determine. The registered agent for said corporation at the above address is Allan N. deLaubenfels, Administrator.

III.

DURATION

The duration of the corporation shall be perpetual.

IV.

PURPOSES

This corporation is not organized for pecuniary profit nor shall it have any power to issue any capital stock, and no part of its earnings shall inure to any member, director or individual. The purposes and objects for which this corporation is formed are as follows:

To promote job training in Northern Idaho; to cooperate with business, industry, schools, public agencies, unions and others engaged in job training and/or placement; to support agencies, firms and organizations

engaged in economic development in Northern Idaho; to plan, manage, oversee, evaluate and otherwise conduct job training programs including those under Public Law 96-300 known as the Job Training Partnership Act (JTPA); to cooperate with all levels of government, local, state and federal and with all interested private individuals and legal entities in the furthering of all such purposes; to accept and use any federal or state aid funds available, and any private funds which may be made available to the corporation for its uses and purposes; to make all necessary studies and surveys, to borrow money, to buy, sell, hold, acquire, own, mortgage, hypothecate, transfer, lease, exchange, trade or otherwise to acquire or dispose of real and personal property; to exercise those powers commonly exercised by natural persons and to do all acts or things useful or incidental to the purposes for which this corporation is constituted.

V.

DIRECTORS






