And we hereby Certify:

FIRST. That the name of said Corporation is *Dewey Canal Co.*

SECOND. That the purposes for which it is formed are *Irrigation of*
Desert lands, domestic and manu
facturing purposes to be used on
Township 8 Range 41 East B.M.

THIRD. That the place where its principal business is to be transacted shall be *St An*
Anthony Fremont Co Idaho

FOURTH. That the term for which it is to exist is *Fifty* years
 from and after the date of its incorporation.


