# ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, do hereby voluntarily associate ourselves together for the purposes of forming a corporation under the provisions of Chapter 11 of Title 30 of the Idaho Code; and we do hereby certify that:

#### ARTICLE I

The name of the corporation is and shall be CHURCH OF THE OPEN BIBLE, OF RUPERT, IDAHO, INC.

### ARTICLE II

The purposes and objects of the corporation are not for profit and are and shall be to establish and maintain a church and to provde a place of and for religious worship and prayer in accordance with the plain teachings of the Holy Bible; to conduct and maintain services for divine worship and religious observance and prayer in accordance with the plain teachings of the Holy Bible; to establish, maintain and conduct schools for the religious instruction of the young; to foster and further religious and charitable work; and for the purposes and objects herein stated, to adopt and establish by-laws, articles of faith, and all rules and regulations deemed necessary and expedient for the management of the affairs of the corporation,/accordance with law and not inconsistent with these articles; and to take, manage, hold and dispose of the property, real and personal, of the comporation; and to do all things necessary for the accomplishment of the objects and purposes herein stated.

#### ARTICLE III

The duration of the corporation shall be and is perpetual.

#### ARTICLE IV

The location and post-office address of the office of this corporation is 3rd and H Streets, Rupert, Minidoka County, Idaho

#### ARTICLE V

A notice of the meeting of the members of Church of the Open Bible for the election of three directors was published in the Minidoka County News issues of September 22 and 29, 1960, it being a newspaper in the City of Rupert, County of Minidoka, State of Idaho, and posted on or before September 22, 1960, on a conspicuous place on the building where said meeting was noticed to be held, namely, at 3rd and H Streets in said City, County and State; pursuant to said notice, and at the time and place specified therein, a meeting of the members of Church of the Open Bible was held at their church at 3rd and H Streets, Rupert, Idaho, at 8:00 PM on Wednesday, October 5th, 1960, for the purpose of electing three directors; Edward M. Anderson was the presiding officer and Donald Helsley was the secretary of said meeting; at said meeting a majority of the members present voted for and elected three directors, namely: Edward M. Anderson, Donald Helsley, and Joyce Helsley.
