ARTICLES OF INCORPORATION

OF

IDAHO SELECT SEEDS, INC.

KNOW ALL MEN BY THESE PRESENTS THAT we, KLAREN KOOMPIN, MARK DUFFIN, and BEN CAVANESS, all residents of American Falls, Idaho, who are all over the age of eighteen (18) years and natural born citizens of the United States of America, do under and pursuant to the provisions of the Idaho Business Corporation Act for the purpose of becoming a body corporate and carrying on all of the busineses hereinafter mentioned, and doing of all things and acts necessary, convenient and/or beneficial thereto and hereby adopt and publish the following Articles of Incorporation for said corporation.

ARTICLE I

The official and registered name of this corporation shall be IDAHO SELECT SEEDS, INC.

ARTICLE II.

That the purposes for which the corporation is organized are to establish and operate a commercial grass, legume, forb, shrub and cereal grain cleaning and merchandising company, and to engage in all other and further acts or activities for which a corporation may be organized under the

laws of the state of Idaho as the same now exist or are hereafter amended.

ARTICLE III

That the address of the initial registered agent and office of said agent shall be c/o Ben Cavaness, 365 Roosavelt, American Falls, Idaho 83211.

ARTICLE IV.

That the corporation shall have perpetual existence unless it is sooner disincorporated according to law.

ARTICLE V.

All provisions for the regulation of the internal affairs of the corporation shall be as provided for in the bylaws of the corporation, including any provisions for restrictions on transfer of shares, as provided for in the Idaho Business Corporation Act at Section 3-=1-23A.

ARTICLE VI.

That the corporate powers, business and property of this corporation shall be exercised by, conducted by, and controlled by a Board of Directors composed of not less

than three nor more than five directors. The Stockholders whose names are subscribed hereto shall act as the directors until their successors have been regularly elected and qualified.

ARTICLE VII.
