

Articles of Incorporation of the Silver City Company

Art- 1st The name of this Incorporation and by which it shall be known is the Silver City Company

Art, 2nd The object of this Incorporation and the business in which it proposes to engage is the Location, Survey, improvement of a certain piece of Ground, at the junction of Long Gulch & Jordan creek, Cuyahua County, Idaho Territory, with the purpose of securing the site of a city to be called Silver City and to secure to the Incorporators thereof, the rights of ownership of the lots & lands located by the Incorporators thereof and to secure to the public the free use of the streets, alleys & public grounds (as the plot filed sets forth) and to engage in improving and building a city

Art- 3rd The amount of the Capital Stock of the Incorporation shall be thirty and thousand and no hundred dollars

Art- 4th The length of time for which this Incorporation shall ~~exist~~ exist shall be fifty years

Art- 5th The number of shares of which the Capital Stock of this Incorporation shall consist shall be one hundred and four of three hundred dollars each

Art 6th The number of trustees who shall
manage the affairs of this Incorpora-
tion for the first three months, shall
be five (viz), A J Sands, H E Clinton Martin
Butler & R Thomas & David Edgerton

Art 7th The principal office of this Incorp-
oration shall be at Silver City Lamy Co
County Idaho Territory
