ARTICLES OF INCORPORATION

OF

FISH PROCESSORS, INC.

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporations Act, adopts the following Articles of Incorporation for such corporation.

- 1) THE NAME OF THE CORPORATION IS FISH PROCESSORS, INC.
 - 2) The period of its duration is perpetual.
- 3) The purpose or purposes for which the corporation is organized are:

Hold and process fish products, fish and to do any and all such activities as may be necessary and consistent with the principal purpose and within the powers allowed by the Idaho Business Corporations Act to all corporations organized under the said statute.

- 4) The aggregate number of shares which the corporation shall have authority to issue is a total of one hundred (100) shares having no par value, which shares shall be common stock. The common shares shall have all rights and powers pertaining to common shares of stock including, but not limited to, the power of vote.
- 5) The Articles and By-Laws shall have no provisions denying preemptive rights.
- 6) There shall be no provision for the regulation of the internal affairs of the corporation set forth in the Articles.
