3. That at said time and place, at least a two-thirds majority of the stockholders present, a quorum being present, duly adopted said proposed amendment as set forth in the Resolution and stated as follows:

RESOLVED, That Section 1 of Article III of the Articles of Incorporation of the COOPERATIVE SUPPLY, INC., P.O. Coeur d'Alene, Idaho, be amended to read as follows:

"Section 1. The amount of the authorized capital stock of this corporation shall be One Million Dollars (\$1,000,000.00) which shall consist of Three Thousand (3,000) shares of Common Stock of the par value of Ten Dollars (\$10.00) each; Ninety-three Thousand (93,000) shares of Preferred Stock of the par value of Ten Dollars (\$10.00) each; and Four Thousand (4,000) shares of Preferred Stock A of the par value of Ten Dollars (\$10.00) each."

BE IT FURTHER RESOLVED, That the President and Secretary of this association be and they hereby are, authorized and directed to make, execute and acknowledge a certificate under the corporate seal of this association and cause such certificate to be filed and recorded in the manner required by law.

IN WITNESS WHEREOF, we, the undersigned, have subscribed our names and caused the corporate seal of the said association to be hereto affixed this 30 day of March, 1972.
